This Corrigendum is here published for in order to make certain amendments in the Expression of Interest (EOI no. NHIPMPL/HQ /2026/GMC/EoI/26-27/04 dated 26.05 2026.

Following are the amendments detailed as follows:

Amendment no. 01: Section -VII; details of pre-qualification criteria for submitting EoI is amended as below:

Clause 1.1 Eligibility criteria for sole applicant firm: (This criteria will be checked after bid opening only when clause 1.1(i) will be qualified and only thereafter prospective bidder will be allowed for presentation)

- iii. Following will be the minimum pre-qualification criteria. Each eligible consultant should possess all the following pre-qualification criteria. Responses not meeting the minimum pre-qualification criteria will be rejected and will not be evaluated.

The CVs and supporting credentials submitted by the bidder shall be verified before the presentation/evaluation stage. In case it is found during verification that the same key expert has been proposed for multiple positions, or any misrepresentation, duplication, or false declaration is detected, the same shall be treated as contempt of the EoI conditions and may lead to rejection of the proposal, cancellation of marks awarded, and further action as deemed appropriate by the Authority.
- The Key Experts shall possess relevant experience in the road sector, including National Highways (NH), State Highways (SH), Expressways, or equivalent highway infrastructure projects.
